Requirements for a deed

Some legal rights can be created without a deed

i. By the grant of a right which can only exist in equity

ii. A contract (agreement) to create or transfer rights in land

Piers agrees to sell his house to Jim

Farmer Wilson agrees to grant an easement for £20,000 to the West

ii. An attempt to create legal right which does not follow the correct formalities
